- Not included in this amount are 77,943 performance-based RSUs of which (i) 23,333 are eligible to vest from 0% to 200% following the end of 2023 and (ii) 31,702 are eligible to vest from 0% to 200% following the end of 2024 and (iii) 22,908 are eligible to vest from 0% to 200% following the end of 2025. Vesting for each award is subject to the Issuer's achievement of certain financial goals and certification by the Compensation Committee of the board of directors of the issuer.
